The contract made and entered into By and between the City of Appleton (MUNICIPALITY), DEPARTMENT, and Bloom Companies, LLC (CONSULTANT) dated June 22, 2011 and amended on March 21, 2012 (Amendment 1), and amended on December 4, 2012 (Amendment 2), and amended on April 17, 2014 (Amendment 3) is hereby amended as set forth on the following pages.

The primary reason(s) for this amendment:

- For the design and plan preparation of a new decorative steel railing along an existing stone
 retaining wall located near the southeast corner of the bridge. The new railing was requested by
 the City of Appleton.
- 2. For the design and plan preparation of a new decorative steel railing at a steep slope located near the northeast corner of the bridge. The new railing was requested by the City of Appleton.
- 3. For the design and plan preparation of a new decorative steel railing at a steep slope located near the southwest corner of the bridge. The new railing was requested by the City of Appleton.
- 4. The addition of a PSE Exception Form.
- 5. The completion date of the contract will be extended 3 months, to November 1, 2014.
- 6. The CONSULTANT will be compensated by the DEPARTMENT for services provided under this CONTRACT on the following basis:
 - (a) Actual cost to the CONSULTANT up to \$103,726.77 (an increase of \$7,629.79), plus a fixed fee of \$6,985.89 (an increase of \$534.09), not to exceed \$110,712.66 (an increase of \$8,163.88) in total.
 - (b) For Subsurface Investigations subcontracted to SES, the CONSULTANT'S actual cost paid to SES based on SES's actual cost not to exceed \$12,582.86 (no change) in total.
 - (c) For Historical Surveys and documentation subcontracted to Elizabeth L. Miller, the CONSULTANT'S actual cost paid to Elizabeth Miller not to exceed \$8,800.00 (no change) using the total direct labor costs listed below.
