Mike,

I had a chance to meet with our facilities person to discuss mowing out at Southpoint. I expressed your concerns and explained why it is important we lead by example as well. While this years contract has already been signed, and we'll likely have B&V hit the grass one more time before the snow flies, we did discuss plans going forward. For 2015, we are going to request a schedule where mowing occurs the first week of June, July, August and Sept. The city will also reserve the right to call them out on an "as needed" basis in the event conditions are right for significant growth and mowing is required prior to the monthly schedule.

I asked our Facilities Dept. to notify me of who we contract with this spring and I will pass that info along to you so you can follow suit if you choose.
