Ord. 58-07: “No Parking/5-Minute Loading Zone on school days from 7:30 a.m. to 4:30 p.m. on the south side of Harris Street from Durkee Street to a point 222’ west of Durkee Street.”

Section 2: This ordinance shall be in full force and effect from and after its passage and publication, and upon its passage and publication, the Traffic Engineer is authorized and directed to make the necessary changes in the Parking District Map in accordance with this Ordinance.

Sec. 7-100. Smoking prohibited in certain areas.

(d) *Prohibition of smoking in outdoor areas.* It shall be unlawful for any person to smoke or use tobacco products in the following outdoor areas.

(4) City parks as posted and so designated by the Parks,

Recreation and Facilities Management Department. Additionally, smoking, vaping, and use of all electronic nicotine devices shall be prohibited within twenty (20) feet of playground equipment located within city parks as well as at the Appleton Skate Park located within Telulah Park.
