On Thursday, August 15<sup>th</sup>, 2013 at 5:00 p.m., the Safety and Licensing Committee of the Common Council for the City of Appleton, Wisconsin, will meet in committee room "A" of City Hall, 100 North Appleton Street, Appleton, Wisconsin, at which time the Appleton Police Department will ask the committee to recommend to the Common Council that it not renew the operator's license issued to **Kyle D. Willenkamp**.

**REASONS FOR INTENDED ACTION PURSUANT TO SECTION 125.12(3) OF  
THE WISCONSIN STATUTES.**

The Appleton Police Department intends to ask for such a recommendation for the following reasons:

On June 8<sup>th</sup> 2012, the Appleton Police Department arrested **Kyle D. Willenkamp** for Operating While Intoxicated (3<sup>rd</sup> Offense). **Mr. Willenkamp** was subsequently convicted of this offense on or about October 23<sup>rd</sup>, 2012.

In addition to this most recent conviction, Mr. Huebner was convicted of the following:




**RECOMMENDATION**
