Emergency Preparedness

- During the third quarter the Emergency Management Coordinator focused on school preparedness utilizing the <u>I Love You Guys</u> protocol and templates, continuity of operations planning, and coordinating training opportunities for Appleton staff. Trainings for staff included arranging damage assessment training, AtHoc training, and fire extinguisher training.
- During this quarter, Octoberfest is a major event that impacts the city greatly. To prepare for this event, a tabletop exercise with a chemical release scenario was developed by the emergency planning team. This tabletop exercise included Fire, Police, Health, Gold Cross EMS, Outagamie Emergency Management, and Outagamie Sheriffs Department. This exercise incorporated secure plans so no after-action report was developed to keep the discussion private. It was a great exercise that will be done annually.
- On September 20th-22nd, the Emergency Management Coordinator participated in the IPAWS training and WEMA Conference. This three-day event provided training and practice on the IPAWS system, presentations on emergency management topics, and finished with a functional exercise on EOC and Command Post interface.



Consumer Protection

• Octoberfest weights and measures inspections have been trending downward for the past 10 years. Prior to the 2022 Octoberfest event, package and labeling requirements were provided via a vendor packet disseminated by the Octoberfest committee. The day of the event is a largely congested and packed experience downtown and makes it difficult to conduct inspections with a large cart and scale. Vendors were contacted in advance of the event and labels were approved. Octoberfest will now be placed on a preventative/complaint-based inspection frequency.
