

Title: Petition against the proposed new concrete sidewalks being constructed for the two blocks of S. Driscoll Street in the city of Appleton within Outagamie County.

Target: To The City of Appleton

Petition Statement:

We, the undersigned residents are writing to express our strong opposition to the construction of new concrete sidewalks on S. Driscoll Street of which entails both sides of the street having sidewalks.

This proposal can pose a financial hardship to many property owners and a possible threat of privacy on one's property depending on the location of their homes footprint.

The concerns of those are as follows:

- Properties with shorter driveways where they currently park their two vehicles end-to-end in their driveway will be in violation of their 2nd vehicle being parked over the sidewalk for if and/or when this would pass could cause a hardship. They'd have two options, park on the street (can park 7 days overnight in a 30 day period) or park on their lawn which they'd also be in violation (Municipal Code Sections 19-91 and 19-92).
- The removal of sound and root established trees so the proposed sidewalk can be constructed. Although, there are some that need to be removed, others are newly planted and currently provide shade and also be for our environment to keep them.
- Past police calls/reports of home owners in regards to individuals casing homes/garages from the street may increase if/when a sidewalk is placed in home owner's front yards having close proximity to the footprint of the residence, furthermore increasing police calls/presence to S. Driscoll Street.
- Many property owners are barely making ends meet with the rising costs of property taxes, their utility bills along with the rise of other essential amenities that we all use or need on a daily basis to live.

The Ask: We implore The City of Appleton to vote against this proposal on new concrete sidewalks and leave our environment in our front yards the way they are.
