Re: Approve Memorandum of Understanding (MOU) with Bird Rides, Inc. to initiate a Dockless, Stand-up

Electric Scooter Program for 2023 and 2024

The 2022 Pilot Program with Bird Rides, Inc. continued to be a success with 58,133 trips and 109,818 miles traveled. The number of trips more than doubled and the number of miles traveled more than tripled over 2021. It has now been two-years since Birds landed in the City and staff feels comfortable with the terms of the agreement and has confidence in our working relationship with Bird Rides. In previous years, there were valid concerns raised by the community that we would like to continue to address.

The major changes to this MOU compared to the 2022 agreement include:

- 1. Continuation of a dockless, stand-up electric scooter program. Moving from the term "Pilot" to the term "Program."
- 2. Term. The term has been proposed as a 2-year agreement.

With the proposed 2-year agreement, it is important to note the inclusion of Section 3.3 Termination. The MOU may be terminated at any point and without cause by either party upon 7 days prior written notice to the other party. The Director of DPW or the Chief of APD may terminate the MOU on behalf of the City.

With two successful years of a pilot program, the City has identified the following components of the MOU that have proven to be beneficial and will remain:

- 1. Reducing the maximum speed in the College Avenue corridor (Drew to Richmond) from 15 MPH to 12 MPH.
- 2. Geo-fencing of downtown bridges to prevent customers from ending their ride on a bridge.
- 3. Creating preferred parking zones where customers receive a discounted price if their ride is ended at those locations.
- 4. Receiving \$0.10 per ride to recoup the City's administrative, educational and enforcement expenses incurred.
- 5. Limiting the number of total scooters to 350 with an initial deployment of no more than 100 scooters in the downtown area (between Wisconsin and Calumet) and 50 north of Wisconsin Avenue and 50 south of Calumet Street.
- 6. Deploying scooters in groups of no more than 10 in any given location.





Globally, we:

- Published an independent Lifecycle Vehicle Analysis, confirming the Bird
 Three has a lifespan of up to 5 years
- Released Bird VPS, the world's first scalable, hyper-accurate visual parking system - powered by Google API
- Continued the Roll to the Polls initiatives, encouraging people to vote with free rides to and from voting locations
- Worked with partners, 3Degrees and Ecocart to offset our greenhouse gas emissions from 2021
