RE:

Variance to setback requirements for Lot 2, CSM 5726 Northeast Business Park

Cancer Specialists of Northeast Wisconsin, LLC recently purchased the above mentioned property with intent to construct an approximately 60,000 square foot, high end medical building for Fox Valley Hematology & Oncology.

CEDD has received a written request for a variance to the setback requirement in the Declaration of Covenants and Restrictions to allow for Cancer Specialists of Northeast Wisconsin, LLC to connect to the Orthopedic and Sports Institute of the Fox Valley building immediately to the south (See attached letter and sketch). Zoning on this parcel is C-2 which does not require any side yard setback. The mutual use of diagnostic equipment and would expand offerings to patients and improve patient care.

Staff Recommendation:

A variance to the Deed Restrictions, Item 2, Lots 29,30 Section E for the Northeast Business Park Plat No. 3, allowing for zero setback to allow for connection to the adjacent Orthopedic Sports Institute building located at 2105 E. Enterprise Drive, **BE APPROVED**.


