RE: Double Frontage Lot Approval Request

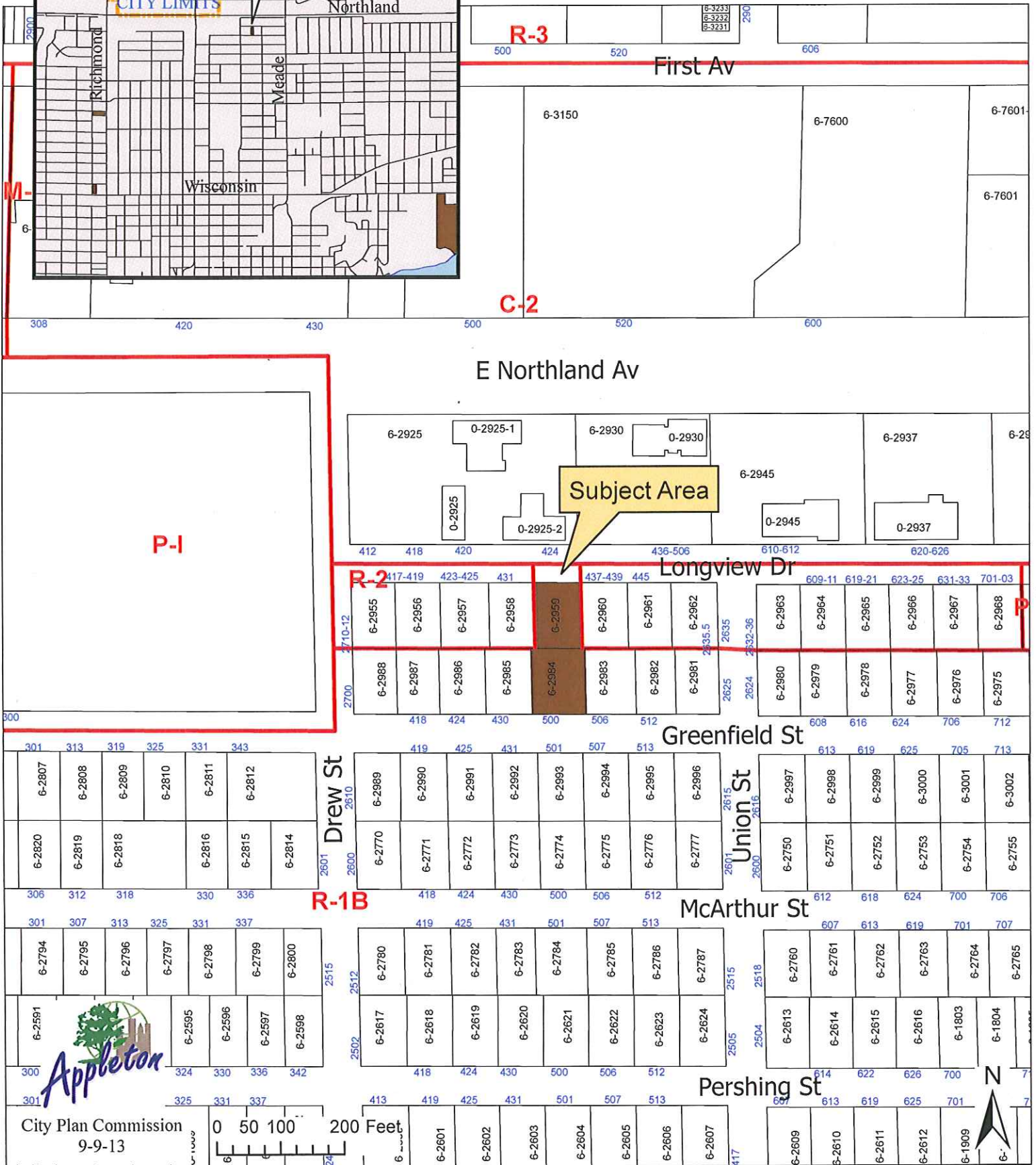
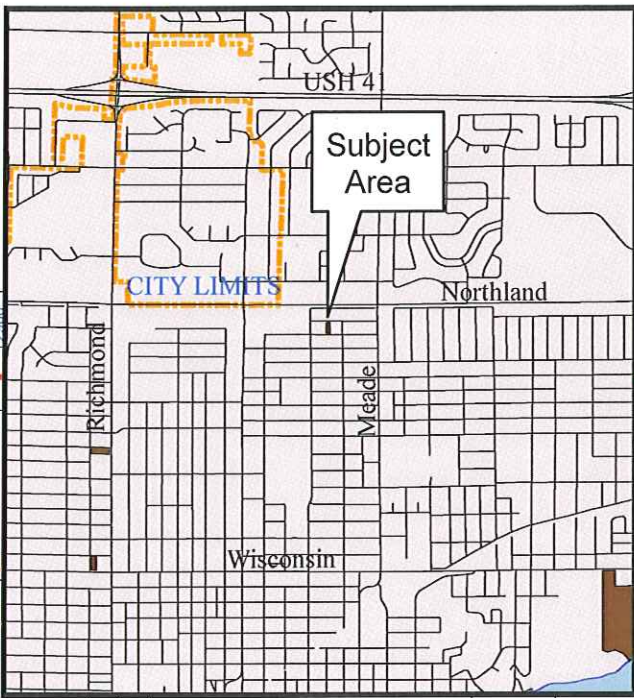
At the July 15, 2013 meeting, the Plan Commission approved the rezoning of a property on East Longview Drive from R-2 Two-family Residential District to R-1B Single-family Residential District so the property owner could combine the two adjacent properties into one lot. This rezoning was then approved by the Common Council at their August 7, 2013 meeting.

The new lot will have frontage on both East Longview Drive and East Greenfield Street. To complete the process of combining the parcels, the creation of this new double frontage lot requires Common Council approval. Under Sec. 17-3(f) of the Subdivision Ordinance, the Common Council may grant relief provided that the modification meets the following three (3) standards:

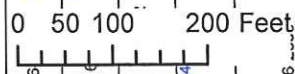
- (1) The modification is due to physical features of the site or its location.
- (2) The modification is the least deviation from this ordinance which will mitigate the hardship.
- (3) The modification is not detrimental to the public interest and is in keeping with the general spirit and intent of this ordinance.

The rezoning process has been completed and a Certified Survey Map to combine the two adjacent lots has been submitted and is under review by staff through the usual Certified Survey Map process. The Plan Commission shall forward a recommendation to Council for action. This action does not approve the Certified Survey Map, but will allow the double frontage lot to be created, so that the Certified Survey Map can be approved by staff and recorded.

East Longview Drive/East Greenfield Street Double Frontage Lot Zoning Map

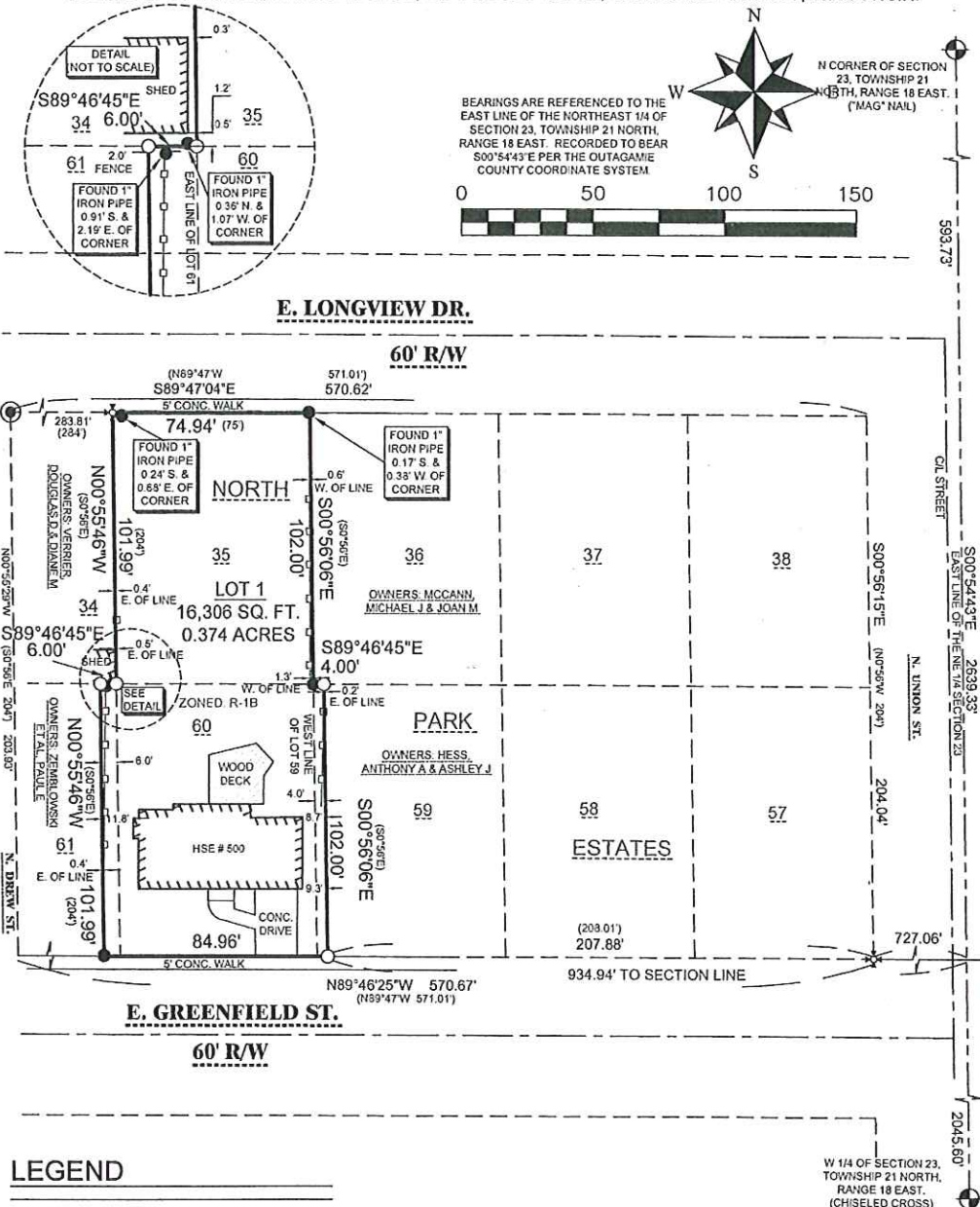
