RE: Final Alarm Sculpture – Fire Station #1

The Appleton Public Art Committee met on September 3, 2019 and recommended approval of the proposed installation of the “Final Alarm” sculpture located at Fire Station #1 (700 N. Drew Street, Tax Id #31-1-0297-00), **subject to the following conditions:**

1. An agreement between the artist and the City will be prepared by the City’s Legal Services Department and shall be executed prior to installation. This agreement will memorialize the expectations of the parties including the location of the art, installation and insurance requirements, maintenance, liability, indemnification, and the like.
2. Prior to installation, the applicant shall provide applicable engineering and structural details for the installation of the sculpture prepared by a structural engineer or other qualified professional.
3. Artist shall provide proof of minimum liability insurance to meet City requirements, prior to installation.
4. Upon completion of the installation, the applicant shall provide certification, by a structural/professional engineer, that the artwork was installed according to specifications and meets required structural standards.
5. The applicant shall coordinate with Parks, Recreation and Facilities Management to determine the exact location prior to installation.
6. Safety perimeter shall be established during the carving of the sculpture.

Applicant is requesting to place a sculpture titled “Final Alarm” at Fire Station #1. The sculpture will be located on the Atlantic Street side of the station. It will be a freestanding sculpture and will be carved on site.

Per the Art in Public Places Policy, the recommendation from the Appleton Public Art Committee is forwarded to the committee of jurisdiction, in this case, the Finance Committee. Please place this item on the agenda for the September 9, 2019 Finance Committee agenda. Their recommendation would then be forwarded to the Common Council for final consideration.

GENERAL INFORMATION

Applicant: Jeffrey Olson and Appleton Fire Department c/o Darrel Baker

Address/Parcel: Fire Station #1 – 700 N. Drew Street (Tax Id #31-1-0297-00)

Applicant's Request: Applicant is requesting to place a sculpture titled "Final Alarm" at Fire Station #1. The sculpture will be located on the Atlantic Street side of the station. It will be a freestanding sculpture and will be carved on site.

PROJECT DETAILS

Brief description of project and location: Applicant is requesting to place a sculpture titled "Final Alarm" at Fire Station #1. The sculpture will be located on the Atlantic Street side of the station. It will be a freestanding sculpture and will be carved on site.

Reason for choosing the proposed location: The applicant chose the proposed location at Fire Station #1 because the sculpture will be honoring Appleton Fire Department firefighters.

Description of how the work is installed/anchored/attached: It will be partially placed in the ground and cement will be poured around the structure for stability.

Timeline and duration of installation: Installation will be permanent. The applicants hope to install and complete the sculpture this fall.

Maintenance and Cost: Upon completion, the limestone sculpture will be sealed to prevent mold and to enhance the stone's colors. The artwork would be maintained by the City because it will be owned by the City. The only maintenance that is identified would be the potential need to power wash and re-seal the sculpture.

Associated Signage: A plaque and/or sign is not initially planned for this location; however, any future sign/plaque would need to be provided to Department of Community and Economic Development Staff for review and approval prior to installation. Per the Art in Public Places Policy, any artwork signage shall

meet the parameters set forth in Zoning Code Section 23-531(e), which allows each artwork one plaque/sign not to exceed nine square feet in size.

RECOMMENDATION

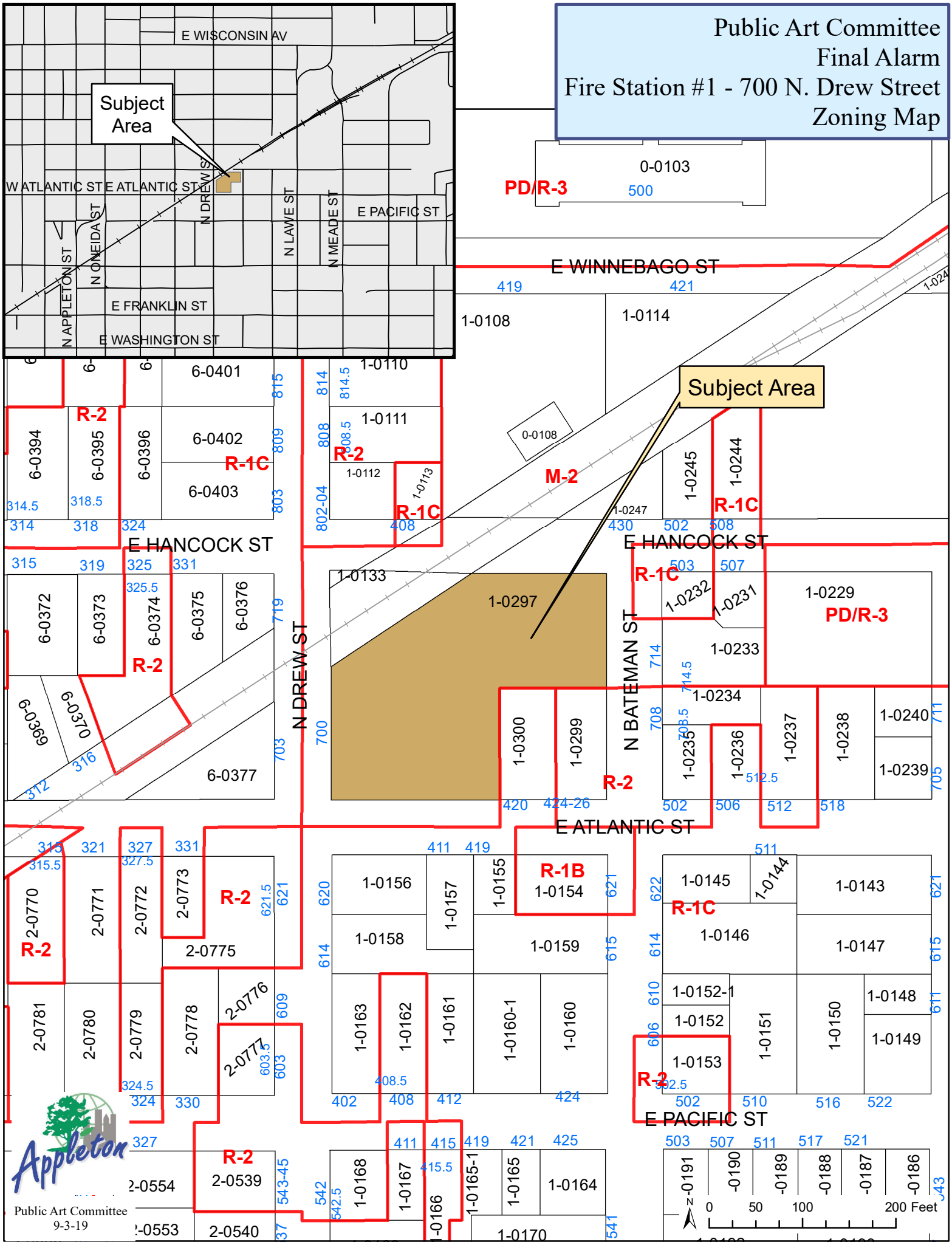

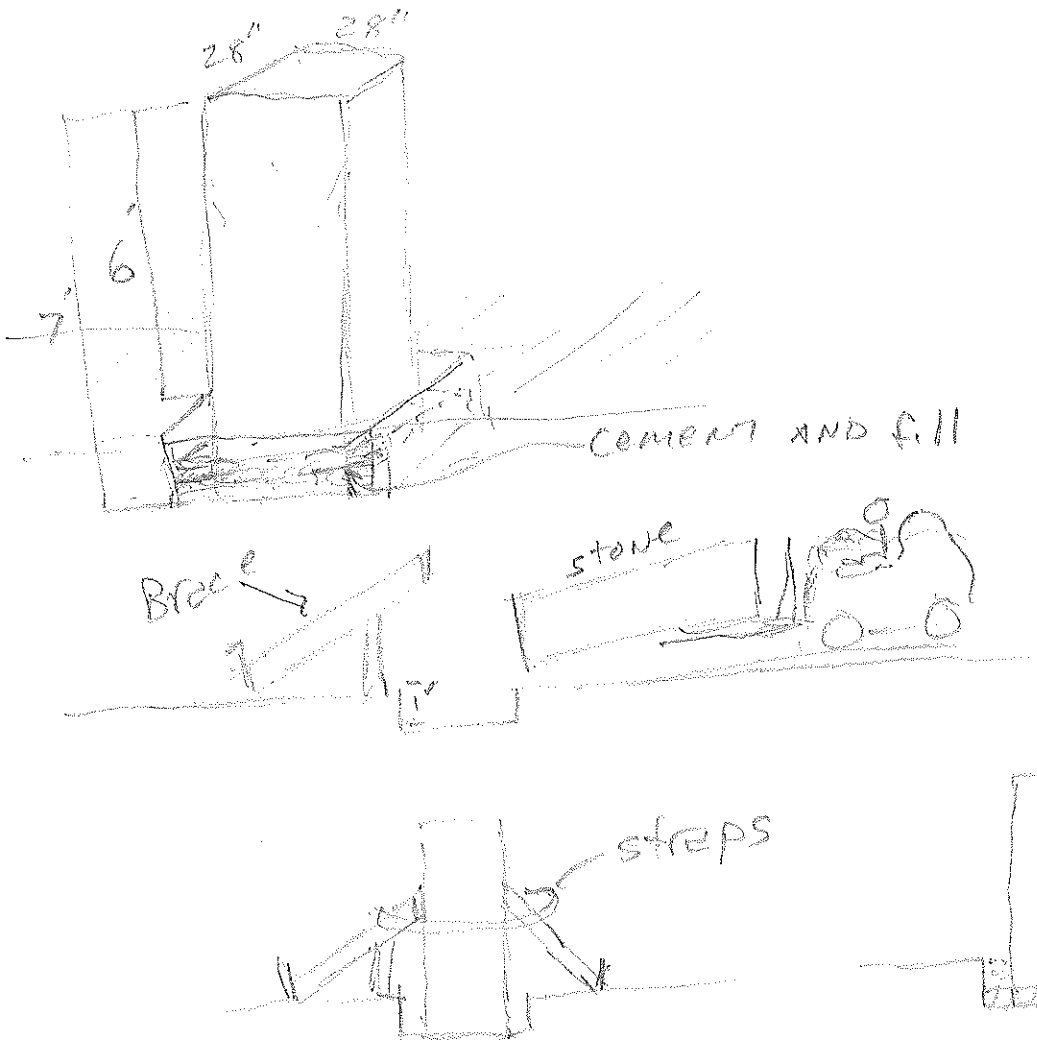


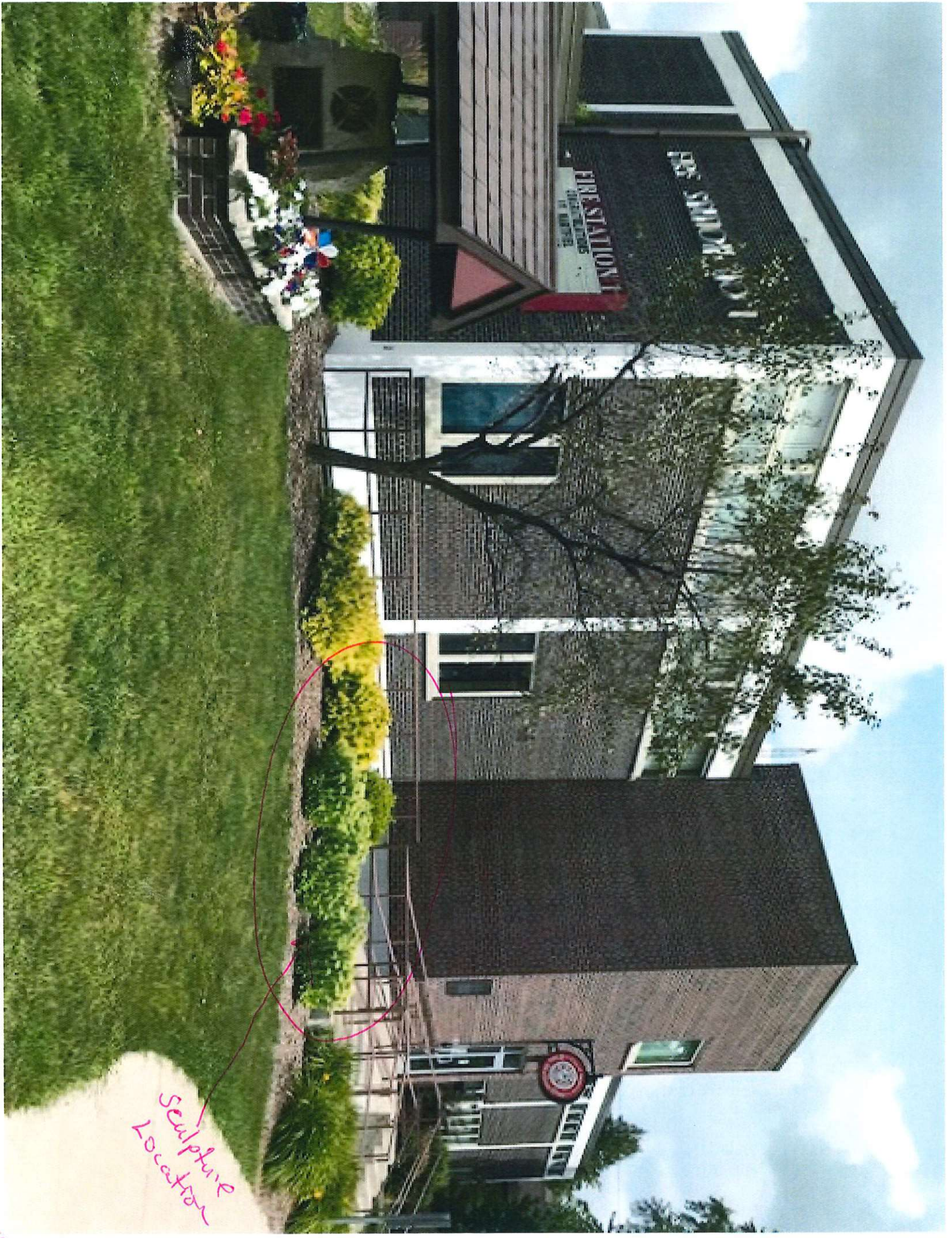

Sculpture==Final Alarm

The Final Alarm will be a limestone carving of a fireman at rest after a call. He will be in the uniform of the Appleton Fire Department and will be emerging from the stone as sketched. The block weighs about 3 ton and will be put partially in ground with cement added to increase the size of the base for stability as shown in the sketch below. I will have the stone delivered on a flat bed truck but will need a lift truck available to remove it from the truck and to place the stone upright in the prepared location. The stone will be braced and cement poured around it. Braces will remain until cement is set and carving begins. I have done the on 6 of the previous limestone sculptures I've done. Once I begin carving on site it usually only takes no more than 2 weeks to finish. I seal the sculpture to prevent mold from appearing on the limestone and to enhance the stones colors. The only maintenance that the sculpture would need would be if the sealant fails in years to come would be to remove the mold with a power wash and reseal. Its been 8 years since the first limestone I did and nothing has been done to it. The sealant only costs \$3.

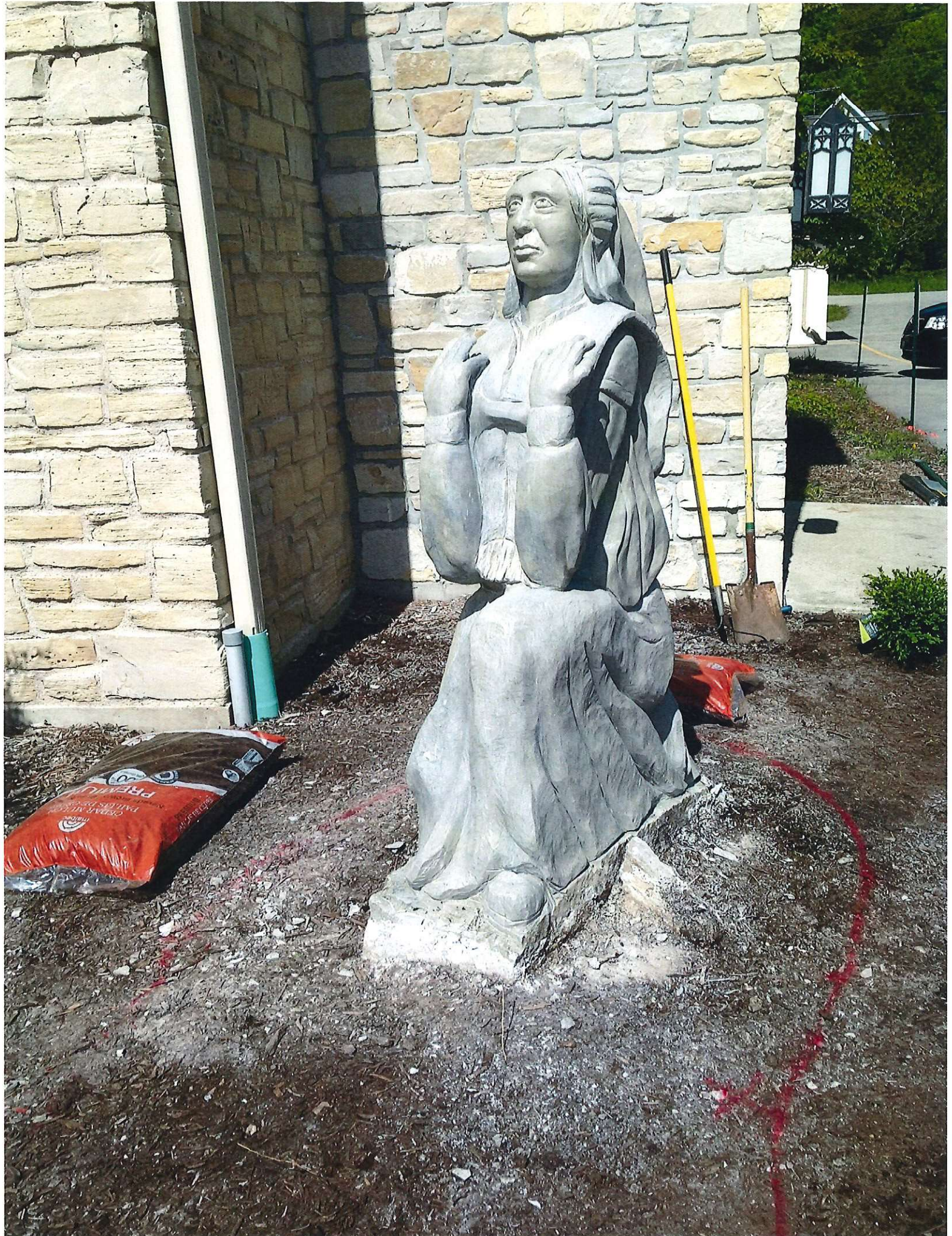
