This most recent incident along with Mr. Huebner's previous arrests clearly show that the defendant, **Ryan Huebner**, has engaged in illegal conduct substantially related to the licensed activity and that he does not possess the qualifications required under Chapter 125 of the Wisconsin Statutes to hold said license.
