The equipment will assist our officers in fighting crime and solving problems in the City of Appleton.

Level 3 Ballistic Shield

The Appleton Police Department (APD) currently has two older ballistic shields. However, neither shield is rated to stop rifle rounds and/or calibers.

In review of recent events occurring locally, within the state, and nationwide, it is evident that the potential threat facing our officers and citizens goes beyond handgun caliber rounds. A Level 3 Ballistic Shield is needed to help mitigate those threats against officers and assist in extricating citizens who face those threats.

The shield would be stored, readily available, in a 24/7 supervisor patrol vehicle - capable of immediate deployment for all patrol officers, police school liaison officers, SWAT, and any other sworn officer in need during a critical incident.

Aimpoint Pro Patrol Rifle Optic with Magpul MBUS flip down rear sight

The Appleton Police Department deploys patrol rifles in all of our marked patrol squads. With this grant, we will use a portion of the funds to upgrade some of the patrol rifles with optics. The addition of the optics will make the weapon more accurate and reliable during critical incidents.

The Appleton Police Department had previously purchased this particular optic model set-up and deployed them on a couple of patrol rifles for testing and evaluation. This testing provided results that support moving forward with this model.
