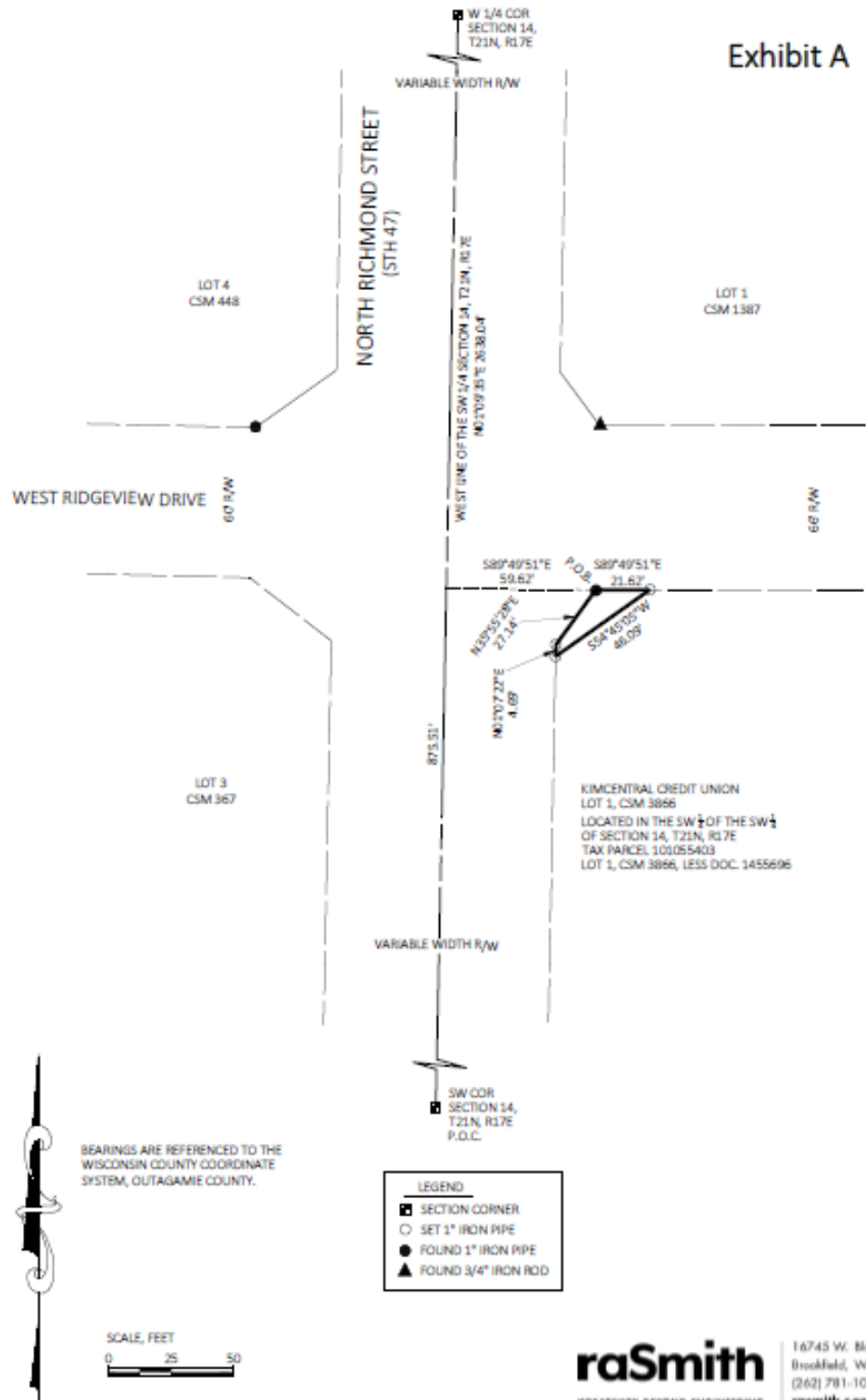

## Legal Description for Acquisition

**Fee Title** in and to all that part of Lot 1 of Certified Survey Map No. 3866, recorded as Document Number 1380209, Volume 20, Page 3866, in the Outagamie County register of deeds, being a part of the Southwest 1/4 of the Southwest 1/4 of Section 14, Township 21 North, Range 17 East, in the Town of Grand Chute, Outagamie County, State of Wisconsin, more particularly described as follows:

Commencing at the Southwest corner of said Section 14; thence North 01°09'35" East, along the West line of the Southwest 1/4 of said Section 14, a distance of 875.51 feet to a point; thence South 89°49'51" East, 59.62 feet to a point on the South right-of-way line of West Ridgeview Drive and the point of beginning of the lands to be described; thence continuing South 89°49'51" East, along said South right-of-way line 21.62 feet to a point; thence South 54°45'05" West, 46.09 feet to a point on the Easterly right-of-way line of North Richmond Street (STH 47); thence North 01°07'22" East, along said Easterly right-of-way line, 4.69 feet to a point; thence North 35°55'28" East, along said Easterly right-of-way line 27.14 feet to the point of beginning.
