RESTORATION OF CIVIL RIGHTS FOR FELONY CONVICTIONS:

The following civil rights are not restored to you:

- 1. Firearms may not be used or possessed unless a pardon is received from the governor.

 2. Public office cannot be held unless a pardon is received from the governor.

The following civil rights are restored to you:

- 1. The obligation for jury duty.
- 2. Your right to vote. You must re-register with the municipal clerk prior to voting.

UNPAID SUPERVISION FEES:

Our records show you have an unpaid supervision fee balance of \$250.00. This balance may change as a result of delayed charges for your last month of supervision and processing any payments made. You are still responsible for unpaid supervision fees even though you are discharging from supervision. You can pay your balance at your local Probation and Parole Office with a cashier's check/money order or online with debit/credit/ACH at https://epay.doc.state.wi.us/. Unpaid supervision fee balances may be sent to the Wisconsin Department of Revenue for collection.

UNPAID COURT OBLIGATIONS OR RESTITUTION:

Prior to your discharge, your agent will have submitted to the court information on unpaid court obligations including restitution. The court may have extended your supervision until you pay these obligations or they may have filed a civil judgment against you for payment of these obligations. The court may submit unpaid court obligation balances to the Wisconsin Department of Revenue for collection. Persons committing crimes after April 9,1990, may have a civil judgment issued for any unpaid restitution.

EXPUNGEMENT OF CONVICTION:

At the time of sentencing if the court ordered that your record be expunded (removed) upon successful completion of probation. your agent will have submitted information to the court upon your discharge indicating whether or not the expungement criteria had been met. The court makes the final determination. You can follow up with the Clerk of Courts in the county of conviction to ensure your record has been expunged.
