

RELOCATION ORDER

1. That this Resolution is a Relocation Order in accordance with subsection 32.05(1), Wisconsin Statutes, for the purpose of the within-described public improvement project and it is also a determination of necessity for that project in accordance with subsection 32.07(2), Wisconsin Statutes;
2. That the City of Appleton hereby determines that it is necessary and of public purpose to construct a detention pond at or near the City of Appleton, Wisconsin for stormwater purposes.
3. That said detention pond will be built within the area marked on the scale drawing, which is attached to this Relocation Order as Exhibit "A" and is incorporated herein;
4. That the legal description for the acquisition necessary for this construction is contained in Exhibit "B" under the heading "Legal Description for Acquisition," which is also incorporated herein;
5. That the City of Appleton will acquire the property described in the "Legal Description for Acquisition" contained in Exhibit "B" from the present owner.
