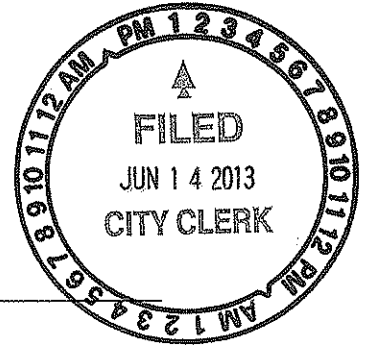

The Petitioner, City of Appleton, by Assistant City Attorney, Stacy Doucette, and the Respondents, Chester's Pub, LLC. and Chester Krawze, Agent, hereby agree and stipulate as follows:

1. That Chester's Pub, LLC and Chester Krawze, as agent therefore, are the license holders of a "Class B" license issued pursuant to Chapter 125, Wisconsin Statutes, and City of Appleton Municipal Code in conformity therewith, for Chester's Pub, located at 2611 North Richmond Street, in the City of Appleton, Outagamie County, Wisconsin.

2. That the following violations of the City of Appleton Municipal Code have been committed at Chester's Pub within the last twelve (12) months:

a. Sale of an Alcoholic Beverage to an Underage Person, violation on July 16, 2012, conviction on September 19, 2012 (80 demerit points);

b. Failure to Vacate/Open After Hours, violation on December 15, 2012, conviction on March 13, 2013 (50 demerit points).

c. Failure to Vacate/Open After Hours, violation on March 9, 2012, conviction on May 22, 2013 (50 demerit points).

3. That the foregoing are all violations of Appleton Municipal Code

adopted pursuant to 125.10, Wisconsin Statutes, and therefore form the basis for suspension of the "Class B" license issued to Respondents.

4. That this Stipulation is based upon the foregoing violations, in lieu of a suspension hearing before the Safety and Licensing Committee of the Appleton Common Council.


5. That the "Class B" license issued to the Respondents will be suspended for a period of ten (10) days, commencing on Monday, July 1, 2013.

6. That on or before 9:00 am on the date the suspension is effective, the Respondents shall deposit the aforementioned license at the City Clerk's Office, located on the 6th Floor at 100 N. Appleton Street in the City of Appleton. The license will remain in possession of the Appleton City Clerk until the suspension has terminated.

7. That a Notice provided by the Petitioner, advising customers of the suspension of the aforementioned license, shall be placed and remain in a conspicuous location(s) at the licensed premises during the entire term of the suspension.


8. That on or after 9:00 am on Thursday, July 11, 2013, the Petitioner shall retrieve the license from the City Clerk's Office.

9. That any further violations of State or local laws or ordinances will result in a suspension or revocation hearing before the Safety and Licensing Committee, during which evidence of any prior violations, including those referred to in the Stipulation, may be used to determine the appropriate penalty.
