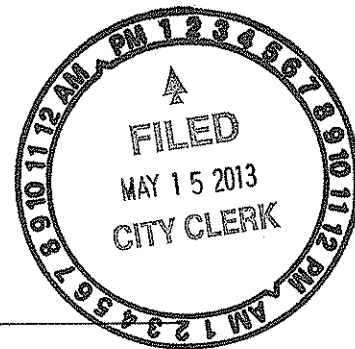

The Petitioner, City of Appleton, by Assistant City Attorney, Stacy Doucette, and the Respondents, DK Petroleum, Inc. and Davinder Singh, Agent, hereby agree and stipulate as follows:

1. That DK Petroleum, Inc. and Davinder Singh, as agent therefore, are the license holders of a Class "A" beer license issued pursuant to Chapter 125, Wisconsin Statutes, and City of Appleton Municipal Code in conformity therewith, for DK Petroleum, Inc., located at 2619 North Richmond Street, in the City of Appleton, Outagamie County, Wisconsin.
2. That the following violations of the City of Appleton Municipal Code have been committed at DK Petroleum, Inc. within the last twelve (12) months:
  - a. Sale of a Fermented Beverage to an Underage Person, date of offense on April 24, 2012, conviction on June 13, 2012 (80 demerit points);
  - b. Critical Retail Health Code violation, date of offense on February 18, 2013, conviction on April 10, 2013 (80 demerit points).
3. That the foregoing are all violations of Appleton Municipal Code adopted pursuant to 125.10, Wisconsin Statutes, and therefore form the basis for suspension of the Class "A" license issued to Respondents.

4. That this Stipulation is based upon the foregoing violations, in lieu of a suspension hearing before the Safety and Licensing Committee of the Appleton Common Council.


5. That the Class "A" license issued to the Respondents will be suspended for a period of ten (10) days, commencing on Monday, June 10, 2013.

6. That on or before 9:00 am on the date the suspension is effective, the Respondents shall deposit the aforementioned license with the Appleton City Clerk. The license will remain in possession of the City Clerk until the suspension has terminated.


7. That a Notice provided by the Petitioner, advising customers of the suspension of the aforementioned license, shall be placed and remain in several conspicuous locations at the licensed premises during the entire term of the suspension.

8. That on or after 9:00 am on Thursday, June 20, 2013, the Respondents shall retrieve the license from the City Clerk 's Office.

9. That any further violations of State or local laws or ordinances will result in a suspension or revocation hearing before the Safety and Licensing Committee, during which evidence of any prior violations, including those referred to in the Stipulation, may be used to determine the appropriate penalty.
