PROJECT DESCRIPTION:

Agreement is for engineering study of traffic operations along CTH KK, from John Street to CTH N. Study will include intersections that are experiencing capacity, travel delay and safety issues to develop short and mid-term improvements that could be made. Study will focus on analysis of traffic signal timings along the corridor, and possible geometric changes, to see if any cost-effective efficiencies can be gained.

Terms and Conditions

- When Federal Funds are involved, the improvement will be subject to the applicable Federal Aid Highway Acts and Regulations of the Federal Highway Administration, U.S. Department of Transportation.
- This is a joint agreement between the County and the signatory agencies. All agencies will be kept informed on the project status and will have input regarding the project. This project will be administered under the County Administrative Rule 10-02, except as agreed to otherwise.
- 3. If the City of Appleton or Calumet County should withdraw the project, it will pay to the County any costs that have been incurred by the County on behalf of the project.
- The project cost in the agreement is an estimate. The City of Appleton and Calumet County will be invoiced periodically, and agree to pay based on actual costs incurred.
- Such costs may be greater or less than the estimated amount, however, the signatory agencies acknowledge that costs between the time this agreement is executed and the actual time of construction can vary.
