Subject: Release of Drainage Easement – Lumbini Estates Plat


The Lumbini Estates Plat was approved by the Common Council on July 17, 2024. This plat identified a 20' Drainage Easement near the rear yard on Lot 15 (Tax Id #31-9-4161-41). The developer's engineer submitted a revised drainage and grading plan to retain the existing trees on Lot 15. As a result of these revisions, the previously required 20-foot drainage easement is no longer necessary. The Department of Public Works has reviewed and approved the revised plan.

Per the Wisconsin Platting Manual, a Release of Easement is the instrument needed to release rights to an easement created on a plat. Pursuant to Wisconsin Statutes §236.293, a release of easement on a plat that changes restrictions for public benefit must be approved by the governing body of the municipality in which the subdivision is located. The requested release of easement appears before Plan Commission and Common Council, since that is the manner in which the plat was originally approved.

RECOMMENDATION:

Release of Drainage Easement for Lot 15 of Lumbini Estates (Tax Id #31-9-4161-41), as requested and shown on the attached maps, **BE APPROVED** subject to the following condition:

1. To formalize the release of the drainage easement, the owner/agent is responsible for completing and recording an appropriate correction instrument with the Calumet County Register of Deeds.
