The reconstruction of Oneida Street from Valley Road to the Skyline Bridge, a total of 1.1 miles, and portions of Calumet and South Olde Oneida Streets.

The MUNICIPALITY and DEPARTMENT deem it advisable to engage CONSULTANT to provide certain engineering services and have authority to contract for these services.

For all authorized and "If Authorized" services in this contract, total compensation shall not exceed \$747,535.17 unless approved by a written CONTRACT amendment. Compensation for costs incurred as a result of improper performance by the CONSULTANT will not be allowed. Details of CONTRACT compensation provisions follow in the text of the CONTRACT and STANDARD PROVISIONS incorporated by reference.
