Dear Mrs. Vandehey,

My name is Lindsey Salzsieder and I am the American Cancer Society, Community Events Specialist. I represent the Sole Burner 5k Walk/Run that will take place on Saturday, May 10, 2014 at City Park, Appleton. I am writing on behalf of the American Cancer Society and the Sole Burner Planning Committee. As an American Cancer Society staff, it is my responsibility is to be the best steward of donor dollars. One of the largest expenses Sole Burner incurred in 2013 was the East Parking Ramp. I had called the Public Works Department a couple weeks ago to inquire about a waiver for the East Parking Ramp and was asked to write a request to your attention.

To recap the previous arrangement, it was to pay \$2.00 per vehicle from 6am – 9am regardless of participation in Sole Burner. In 2013 we paid for 749 vehicles which removed \$1,588 from our fundraising totals not including the additional \$1,500 for the City Park Permit and processing. Therefore, I am requesting the City of Appleton to please waive the fee based upon the following:

- Sole Burner brings around 6,000+ people to the "Premiere Entertainment District". Many of these participants
 and their families will likely make purchases of fuel, food and/or retail benefiting the city. In addition, we are in
 the process of partnering with Appleton Downtown to hold a post event Farmers' Market to increase
 community engagement.
- When you partner with the American Cancer Society, you are supporting the largest voluntary health organization in the world with 98% brand recognition.
- The American Cancer Society has provided programs and services locally at no cost to729 cancer patients in 2013 and will continue to do so in 2014. Programs and services are made possible by funds raised through events such as Sole Burner. These services include transportation (Road to Recovery), counseling (Look Good Feel Better/Patient Navigator) and lodging. Additionally, most lifesaving treatments were somewhat funded by the American Cancer Society.

- Participants come from 16 states
- 5000+ females alone with the most common age of 30-39
- Ages range from toddlers to the oldest participant at the age 84
