





Regarding: Core’s Lounge Noise Allegations

Chief Thomas:

I have been requested to provide information regarding the noise complaints related to **Core’s Lounge, 1350 W. College Avenue**. There have been several calls for service at this location for allegations of loud noise dating back to 2019, according to the information I have been provided.

In my conversations with some of the residents expressing the concerns, I was told this property was originally not zoned for alcohol sales; however, the residents in the area approved it for a wine bar. This establishment has moved and now the property is a bar, or nightclub, type of business.

The typical time for the calls for service has been around 2300—0200 Hrs. The complaint is typically focused on loud bass music coming from the building, which is a steel, multi-unit commercial building.

Captain Freeman worked with APD Records to obtain reports and data from 01/01/20 until the present to share with the Common Council.

Complaint History

There are 61 calls for service for noise complaints at 1350 W College Ave. For these 61 calls there are the same three names listed as complainants. These three citizens live in the area north of Core’s Lounge, a satellite view of the neighborhood with the addresses is included on page 3. Seven of the calls are *anonymous* or *no complainant* is listed.

Callers (several listed as first name only in the call)

- Amy Annen (1344 W Washington): 22 calls
- Joanne Kizewski (1339 W Washington): 24 calls
- Jane Kampf (1347 W Washington): 8 calls
- Unknown/Anonymous: 7 calls

The municipal ordinance most easily applied is the “75-foot rule”, which is city ordinance 12-87;

“Sec. 12-87. Radio or other electric sound amplification device – prohibited. No person or business may use a radio or other similar electric sound amplification device so that sound emitting from said radio or amplification device is audible under normal conditions from a distance of seventy-five (75) or more feet.”

Under the legal advice of Assistant City Attorney Glad, the noise beyond 75 feet must still be reasonably audible to be enforceable and to issue a citation for a violation of 12-87,

Some key points regarding our involvement in this:

- APD and Appleton Department of Health have met with the business in the past and employed use of a decibel meter. It was noted by Sgt. Ryan that the only time the sound was a concern was when it was set at its maximum volume.
- The owners were eager to meet with us to try to resolve the issue.
- Officers have asked the business, as a courtesy, to turn down the music when a violation was not established and, despite not being required to, they complied.
- Officers have been assigned to park and monitor the area to try and detect any violations before complaints came in.
- A request has been made with the dispatch center to not send calls over the radio (to address any possibility of a scanner in Core’s Lounge).
- I have had multiple phone conversations with the callers. One caller expressed concerns of hearing music in her room. I requested that she take the officer to where she hears the noise in her house, but she will not do so. (Note: one earlier report notes she did accommodate this, and the reporting person concurred with the officer that the noise heard was not a violation).
- Captain Frisch and I have had conversations with Alderperson Smith about this concern.
- Officers have deployed various types of sound measurement tools and have found readings in the 35-50db range, under the levels allowed by ordinance in a residential district.
- Several times, when noise could be heard, the officer had to be within approximately ten feet of the building to hear it.
- Rarely, some noise could be heard at distances beyond 75 feet, however it was not determined to be reasonably loud enough to allow for a citation. (One citation had been issued in late 2019, 45 demerit points were assessed).
- Several times we used tactics to avoid the business knowing of our presence (by responding to Washington Street first, not dispatching the call over the radio, etc.).
- Of the 61 calls only two appear to have risen to a level where officers could have possibly taken enforcement action, both occurring in 2020. The bar was cooperative each time and turned down the volume.

Neighborhood Canvas



On 06/17/21 during the late morning hours, Captain Freeman and I conducted a random canvass of the 1300 & 1400 blocks of W. Washington St. Our conversations with residents were based on a general overview of quality-of-life concerns. As people spoke of some concerns (speeding, potholes, etc), we eventually asked some more direct questions about this issue. **Nobody identified the music noise as a concern, some of whom live as close to Core's Lounge as two of the primary historical complainants.**

The following are the comments of different neighbors of the business:

- Only concern is foot traffic in the yards. When asked, noise from the retail area was not a concern. Resident for 17 years.
- Concern is homeless foot traffic. When asked about noise, only vehicle noise noted. Individual sleeps with windows open and does not hear Core's Lounge music. Resident for 2 years.

- Concern is bicycle and foot traffic. Occasional street racing noise on College Avenue. Home all the time. When asked about Core's Lounge, he replied she "didn't even realize there was a bar there." Resident since end of March 2021.
- Concern is potholes. Person is very close to Core's and never voiced a concern. When asked about the noise they said they know some people, indicating the known complainants, notice it but they do not.
- Citizen has lived in their house for 7 years, all is well – occasional traffic and racing-like noise on W. College Avenue but no Core's Lounge noise concerns.
- Citizen who has lived there for 4 years – knows other neighbors have an issue with Core's Lounge noise but has not heard anything. They did mention that Little Caesar's staff sometimes has friends in their parking lot with loud stereos, but that is very infrequent.
- Citizen who has lived very near Core's Lounge location for 10 years. They know some neighbors have issues with Core's, but this person does not hear it. This person reports hearing noise from the bar when returning home later at night but described it as "reasonable." This person told me Tandem Wine Bar was a noise issue when it was there.
- We knocked on 5-6 other doors without making contact.

Specific Calls and Actions Taken

These provide examples of efforts made by APD and the observations of some officers.

- **A21019776:** "...Sound was barley heard, and there was no loud bass. I went around the building itself and only noticed the sound once I was within five or so feet of it. At no point was any loud bass heard. There was no noise violation and no reason to tell them to turn down the music..."
- **A21017891:** I heard several patrons leave the bar, and their voices could be clearly heard. I could not hear any music. I then parked near the parking lot for a time, and I could not hear anything over the passing traffic on College Ave.
- **A21010948:** I was requested by Lt. Berkley to address any potential noise violations that were a reoccurring issue at Cores' Lounge located at 1350 W. College Ave, in the City of Appleton. On 3/26/21 from the hours of 2320 to 0020 I sat directly in front of 1345 W. Washington St, which was directly behind Core's Lounge. I sat within my squad with the windows down and periodically exited to assess any noise omitting (sic) in the area. Inside the squad with the engine running while I kept it warm, I was not able to hear any sound from Core's. When I exited, I overheard the occasional bass note emanating from Core's, but it was extremely faint and not even close to be considered a violation. I was not able to clearly identify specific music being played inside the building, and only heard the faint bass note time to time, but it was not a constant issue.

As I stood upon the sidewalk of Washington St and even within my squad, I was able to hear the passing of vehicles on College Ave louder than any noise coming from within the bar. There were also few individuals who stepped outside the back around 2351 hours, and I was able to hear their voices clearer than any music from the building.

Shortly after midnight, the resident of 1339 W. Washington St approached my squad to tell me that the lack of noise was unusual, and it was louder before I arrived. She claimed that the occupants of Core's knew I was sitting on the road. I found this unusual as my squad was blocked by the residence of 1345 W. Washington St, and nothing was dispatched over the radio to indicate I was here. She admitted to me that she was unable to hear anything where my squad was parked, which typically did not happen, and it was much quieter. I informed her that I would continue to monitor the situation.

I think with this reoccurring issue, it is possible it's not the music level itself within the bar, but the bass reverbing off the sheet metal walls. With what I observed over a span of an hour, I would be unable to enforce any violation.

- **A21010048:** On 3/20/21 at approximately 00:55 hours, I, Officer Shuman #9173, was dispatched to the address of 1350 W College Ave, Core's Lounge, for a noise complaint. I **was already on scene for the complaint**, as I had been directed by LT Del Plaine #9156 to conduct extra-patrol in the 1300Blk of W Washington St for numerous previous complaints of loud music coming from the bar.

I responded to the area at approximately 23:40, and placed myself on a community policing status. At approximately 00:07 hours I performed foot patrol in the area and overheard no loud noise coming from the area of the bar. I walked down several driveways in the area and could not hear any music at that time. I returned to my squad car and worked on several reports with my windows open. During this time I heard the a door open to the bar and someone threw away several glass bottles into a dumpster. This was the only loud noise I heard until I noted that dispatch had screened up a noise complaint for the bar at approximately 00:55. Prior to them dispatching the call over the air, I exited my squad car and walked through the driveway of 1347 W Washington towards the bar. I continued to walk towards the building until I was approximately 6-10 feet from the backdoor to the bar, where I could begin to overhear some music from inside.

I called the RP back and spoke with her shortly. Jane advised that the noise had been going all night, which she described as "bass thumping." I described to her that I had been on scene for a long time and had not heard anything. Jane questioned whether she should call in complaints or not. I informed her that she should call about issues she has in the community, but understand that we many (was this "may" in original) not have the ability to make any changes if the volume was the same as it was tonight.

Jane explained that her neighbor has a worse experience and that she usually hears it more by her house, (1339 W Washington.).

I later was able to walk around the property of 1339 W Washington, and while the noise from the bar is louder on the East side of Core's lounge, the music did

not extend to the backyard of 1339.

I informed Jane that possibly it was quieter tonight than usual, but it was far from a violation.

I noted during my entire time on scene that passing traffic on College Ave was the predominant source of noise, and that even while standing behind the bar and listening for any type of music, I could always hear traffic passing by on College Ave over any other noise.

END OF REPORT

Upon my return to duty on 3/20/21, I, Officer Shuman #9173, was advised by Lt del Plaine that the front desk staff had advised that Jane had told them that the music had started as soon as I pulled away from the house the night, she called in the complaint. I briefly listened to the beginning of the call, and overheard Jane tell the front desk that the music coming from the bar had gotten louder once the officer left the area.

I asked the front desk staff to save the call for future use.

I re-watched my recording of speaking with Jane, and noted that she was unaware that I had not left the area while first speaking with me. She referenced coming outside while I was on scene, and not being able to hear anything. She then said that the music was turned up later in the night prior to her calling. I was on scene the entire time she refers to, and never left the area. At no point did I leave the area of the 1300Blk of W Washington St, and at the time of her calling I was parked with my windows open directly in-front of her house. I noted no change in music volume, and was unable to hear anything while on or near Jane's property.

On 3/20/21 at approximately 23:56 hours, I Officer Shuman #9173, was advised by the front desk that they had received a call from the resident of 1344 W Washington St about loud music coming from Core's Lounge. I had been on scene in the 1300Blk of W Washington St for approximately 45 minutes, as assigned by Lt Del Plaine. I had noted upon foot patrolling the area that the music coming from the bar was audible from the back fence line of 1339 W Washington St, which borders the bar's property line. This music was only audible if I stood still and listened closely. Any other noise nearby, such as a dryer vent or furnace turning on drowned out the sound of any music able to be heard.

While on scene I was able to hear that the noise from the bar would increase drastically when the side door on the east side of the building was opened or when people were out in front of the bar, but this noise was always temporary and ceased when the doors shut.

I spoke with Amy over the phone, and she advised that while she was able to hear the bass or rhythm line of the music from her house at 1344, she did note that the music has been substantially louder in the past. In speaking with Amy, she noted that the music, specifically the bass line, at the time of speaking with me, was audible if she stepped out onto her porch. I listened as she was speaking, and from my squad car I was unable to hear anything from the bar. While speaking with her for approximately 40 minutes, I heard several people exit the bar, and once I was able to hear what sounded like a bass line from a song. This noise was not overly loud, but present. My vehicle was parked what I would approximate as around 150 feet from the property line of the bar. This noise lasted for approximately 30 seconds to a minute, and ceased, it never raised to the point of being audible over the noise from traffic on College Ave.



The loudest noise I heard while on scene were patrons leaving the bar, many of which were loud and boisterous. They often cheered and yelled loudly, but left in intermittent intervals and were not consistent. Their conversations were loud enough for me to clearly understand what they were saying when speaking in English. I was unable to understand other conversations due to the foreign language being spoken, but it was loud enough for someone who speaks the language to hear.

Here is the information on the 2 (two) complaints that were *potentially actionable*, based on the details in the call:


- **A20015788:** 05/23/2020. Nou and several bar patrons were playing music too loudly for the local neighborhood. The music could be heard from approximately 1 1/2 blocks away, outside of local noise variance. Nou was verbally warned.
- **A20044773:** 12/19/2020. Noise complaint at Core's lounge where I could hear the music clearly from neighboring driveways to the north. I spoke with staff who were compliant in turning the music down. Sgt. Ryan notified due to ongoing issue with neighbors and business.

I am hoping this provides some information to help show our efforts and observations. There were two instances last year when officers possibly observed excessive noise but felt it appropriate to handle the situation with a warning and working with the cooperative business. This is consistent with department expectations and how these complaints are handled with other businesses in other locations in the city. As noted, most residents in the immediate area did not feel Core's Lounge was a source of disruptive noise.



On 1/3/2020 at 2225 hours, I, Officer Jason Schmitz #9115 was dispatched to Core's Lounge located at 1350 W. College Ave, in the City of Appleton, Outagamie County, Wisconsin for a noise complaint. This business has been subject to numerous other recent noise complaints by the same complainant (A19044988; A19045891, A19046178, A20000270). All were unfounded. Dispatch

advised there was loud music emitting from the exterior of the building, which the complainant could hear from the second story within her residence.

I arrived on scene and walked around the exterior of the building. I heard music within the building while I stood from a few feet away, but the level was appropriate and did not seem to be a disruption. The only sound I was able to clearly hear was occasionally the bass from the music. There were no exterior speakers attached to the building.

I downloaded a Sound Level Meter app on my phone. Obviously, the true accuracy of the app is unknown, but within a few feet away from the building in the back, the app registered between 43-48DB. Loud talking and laughter within the building was louder than the actual music. In the front of the building, the app registered between 40-46DB.

I walked to the driveway of a residence directly behind the business. In the middle of the driveway, near the residence itself the app registered between 34-37DB. In comparison, while exiting my squad the closure of my car door registered around 80DB.

I stood outside for several minutes, and only heard the occasional bass note emitting from the business. The sound was at a low level, and I did not observe any violation for loud or excessive noise. I attempted to call the complainant, but I did not receive an answer. I later heard back from the complainant who stated that the noise was now turned down and she could no longer hear the music.

The complainant asked me several times if she was the only one who called in the noise complaint. I informed her she was, and the front desk received a phone call from someone else reporting the issue moments after I ended my conversation with the original complainant.

No violation observed. Due to the on-going issue, report was completed for record.

On 3/20/21 at approximately 00:55 hours, I, Officer Shuman #9173, was dispatched to the address of 1350 W College Ave, Core's Lounge, for a noise complaint. I was already on scene for the complaint, as I had been directed by LT Del Plaine #9156 to conduct extra-patrol in the 1300Blk of W Washington St for numerous previous complaints of loud music coming from the bar.

I responded to the area at approximately 23:40, and placed myself on a community policing status. At approximately 00:07 hours I performed foot patrol in the area and overheard no loud noise coming from the area of the bar. I walked down several driveways in the area and could not hear any music at that time. I returned to my squad car and worked on several reports with my windows open. During this time I heard the a door open to the bar and someone threw away several glass bottles into a dumpster. This was the only loud noise I heard until I noted that dispatch had screened up a noise complaint for the bar at approximately 00:55. Prior to them dispatching the

call over the air, I exited my squad car and walked through the driveway of [REDACTED] W Washington towards the bar. I continued to walk towards the building until I was approximately 6-10 feet from the backdoor to the bar, where I could begin to overhear some music from inside.

I called the RP back and spoke with her shortly. Jane advised that the noise had been going all night, which she described as "bass thumping." I described to her that I had been on scene for a long time and had not heard anything. Jane questioned whether she should call in complaints or not. I informed her that she should call about issues she has in the community, but understand that we may not have the ability to make any changes if the volume was the same as it was tonight.

Jane explained that her neighbor has a worse experience and that she usually hears it more by her house, [REDACTED] W Washington.).

I later was able to walk around the property of [REDACTED] W Washington, and while the noise from the bar is louder on the East side of Core's lounge, the music did not extend to the backyard of [REDACTED]

I informed Jane that possibly it was quieter tonight than usual, but it was far from a violation.

I noted during my entire time on scene that passing traffic on College Ave was the predominant source of noise, and that even while standing behind the bar and listening for any type of music, I could always hear the sound of traffic passing by on College Ave over any other noise.

Upon my return to duty on 3/20/21, I, Officer Shuman #9173, was advised by Lt Del Plaine that the front desk staff had advised that Jane had told them that the music had started as soon as I pulled away from the house the night she called in the complaint. I briefly listened to the beginning of the call, and overheard Jane tell the front desk that the music coming from the bar had gotten louder once the officer left the area.

I asked the front desk staff to save the call for future use.

I re-watched my recording of speaking with Jane, and noted that she was unaware that I had not left the area while first speaking with me. She referenced coming outside while I was on scene, and not being able to hear anything. She then said that the music was turned up later in the night prior to her calling. I was on scene the entire time she refers to, and never left the area. At no point did I leave the area of the 1300Blk of W Washington St, and at the time of her calling I was parked with my windows open directly in-front of her house. I noted no change in music volume, and was unable to hear anything while on or near Jane's property.

-

On 3/20/21 at approximately 23:56 hours, I Officer Shuman #9173, was advised by the front desk that they had received a call from the resident of [REDACTED] W Washington St about loud music coming from Core's Lounge. I had been on scene in the 1300Blk of W Washington St for approximately 45 minutes, as assigned by Lt Del Plaine. I had noted upon foot patrolling the area that the music coming from the bar was audible from the back fence line of [REDACTED] W Washington St, which borders the bar's property line. This music was only audible if I stood still and listened closely. Any other noise nearby, such as a dryer vent or furnace turning on drowned out the sound of any music able to be heard.

While on scene I was able to hear that the noise from the bar would increase drastically when the side door on the east side of the building was opened or when people were out in front of the bar, but this noise was always temporary and ceased when the doors shut.

I spoke with Amy over the phone, and she advised that while she was able to hear the bass or rhythm line of the music from her house at [REDACTED] she did note that the music has been substantially louder in the past. In speaking with Amy, she noted that the music, specifically the bass line, at the time of speaking with me, was audible if she stepped out onto her porch. I listened as she was speaking, and from my squad car I was unable to hear anything from the bar. While speaking with her for approximately 40 minutes, I heard several people exit the bar, and once I was able to hear what sounded like a bass line from a song. This noise was not overly loud, but present. My vehicle was parked what I would approximate as around 150 feet from the property line of the bar. This noise lasted for approximately 30 seconds to a minute, and ceased, it never raised to the point of being audible over the noise from traffic on College Ave.

The loudest noise I heard while on scene were patrons leaving the bar, many of which were loud and boisterous. They often cheered and yelled loudly, but left in intermittent intervals, and were not consistent. Their conversations were loud enough for me to clearly understand what they were saying when speaking in English. I was unable to understand other conversations due to the foreign language being spoken, but it was loud enough for someone who speaks the language to hear.

I was requested by Lt. Berkley to address any potential noise violations that were a reoccurring issue at Cores Lounge located at 1350 W. College Ave, in the City of Appleton. On 3/26/21 from the hours of 2320 to 0020 I sat directly in front of [REDACTED] W. Washington St, which was directly behind Cores Lounge.

I sat within my squad with the windows down and periodically exited to assess any noise omitting in the area. Inside the squad with the engine running while I kept it warm, I was not able to hear any sound from Cores. When I exited, I overheard the occasional bass note emanating from Cores, but it was extremely faint and not even close to be considered a violation. I was not able to clearly identify specific music being played inside the building, and only heard the faint bass note time to time, but it was not a constant issue.

As I stood upon the sidewalk of Washington St and even within my squad, I was able to hear the passing of vehicles on College Ave louder than any noise coming from within the bar. There were also few individuals who stepped outside the back around 2351 hours, and I was able to hear their voices clearer than any music from the building.

Shortly after midnight, the resident of [REDACTED] W. Washington St approached my squad to tell me that the lack of noise was unusual, and it was louder before I arrived. She claimed that the occupants of Cores knew I was sitting on the road. I found this unusual as my squad was blocked by the residence of [REDACTED] W. Washington St, and nothing was dispatched over the radio to indicate I was here. She admitted to me that she was unable to hear anything where my squad was parked, which typically did not happen, and it was much quieter. I informed her that I would continue to monitor the situation.

I think with this reoccurring issue, it's possible it's not the music level itself within the bar, but the bass reverbing off the sheet metal walls. With what I observed over a span of an hour, I would be unable to enforce any violation.
