

The 2015 Capital Improvement Plan includes \$200,000 for a replacement of the east section of the roof, in addition to making repairs to the atrium. Though repairs have been made to keep the atrium from leaking, this contract will implement long term repairs. Our annual roof inspection program identifies roofing in need of replacement and allocates resources to allow for proactive replacement to protect and preserve the facility's asset.

In closing out 2014, the following funds showed expenditures in excess of budget. I am requesting budget adjustments to bring them back into compliance.

Grant Funds

All of the grant fund budget adjustment requests (HAZMAT, CDBG, Emergency Shelters and Housing Rehabilitation) are the result of increased grant revenues (thus increased expenditures) in 2014 or the timing of grant expenditures in relation to the timing of revenues received. All excess expenditures are funded by the additional grant revenues or existing fund balances within the grant funds.

Room Tax Fund

Of the hotel room tax remitted to the City, 5% is kept to cover administrative expenses and 95% is forwarded to the Fox Cities Convention and Visitor's Bureau. The excess expenditure in 2014 is a result of higher room tax collections than budgeted, thus a higher amount turned over to the Convention and Visitor's Bureau.

TIF 7 Fund

TIF 7 boundaries are basically the former Valley Fair shopping center site on the City's south side. The TIF is considered a "developer funded" TIF whereby the developer pays for the costs of the improvements and is paid back by a portion of the increased property tax revenues generated from the increased property values. The excess expenditures in 2014 represent increased developer payments due to higher than budgeted property tax revenues generated by the TIF.

RE: Fire Department 2014 Budget Variance

Preliminary results for the general fund for 2014 show just the Fire Department exceeding their budget appropriations for the year. The \$116,714 variance is due to a 3% wage increase for represented staff that was negotiated after the budget was prepared. Since the increase was not certain at the time of budget preparation, it was not factored into the Department's salary budget at the time.

The total estimated cost for the 3% increase was \$253,272, so Fire Department staff did a good job saving in other areas to bring the total variance to only \$116,714.

Although the variance is eligible to be funded by the Wage Reserve, in order to preserve that funding for future years, I'm recommending no wage reserve be allocated in 2014 and the variance be absorbed by other general fund department's budget surpluses. For audit purposes, no budget adjustments are necessary since the department is part of the general fund, and the general fund, in total, shows a positive budget variance.
