Given the timing of this finding and the impact it would have on programming and layout of the 2018 fall elections, and the fact that the new territory does not and will not contain any voters, there was no immediate correction made to the Ward of the annexed territory. Now provides an adequate time to make the correction to the Leona Pond Annexation by creating a new City Ward, Ward 60.

The correction of Ordinance 37-18 will be coming forth as an ordinance at a future Council Meeting and once adopted and published, an Affidavit of Correction will be filed with the Register of Deeds and Wisconsin Elections Commission to make the new Ward designation official. Ward 60 will be in Aldermanic District 2.


