#### 2020 Cares Act Summary

- Mar 27, 2020: FY2020 CARES ACT SECTION 5307 URBANIZED AREA APPORTIONMENTS Appleton, WI: \$7,425,047
- June 30, 2020: Valley Transit Obligated \$2,000,000 through a FTA grant application
- July 01, 2020: Budget Amendment for \$500,000 approved by City of Appleton Common Council
- Dec 31, 2020: End of year CARES Act expenses; \$308,902 (unaudited) Remaining obligated grant money \$1,691,098
- Mar 01, 2021: Valley Transit will request a 2021 budget amendment for a portion of remaining obligated grant money
- Mar 01, 2021: Unobligated grant money remains \$5,425,047 (unobligated means the money hasn't been entered into a grant application)
