- Emergency Management Coordinator, Cassidy Walsh, received training on damage assessment and how the state wants locals to report after an incident.
- COVID-19 Fellow, Breanna Mekuley, has joined AHD, and has been focusing on the day-to-day management of health department COVID-19 community activities (outreach, distributing test kits).
- Emergency Management Coordinator, Cassidy Walsh, led a Train Derailment Exercise on June 6th, the first tabletop emergency exercise since the COVID-19 pandemic.



- Partnerships with Building for Kids

 - All kids 12 and under who attend a vaccine clinic at the BFK for the first time will receive a FREE 3-month membership to the Building for Kids when they receive their first, second, or booster shot. Families can also play in the museum for free before and after their vaccination.
 - Volunteers & AHD staff will be present (14/clinic)

Community Interaction

- Pillars (we ordered antigen tests though the state & delivered to Pillars to be used to test clients when they symptoms or have been in close contact with a positive case)
 - Aug 3 400 tests
 - July 21 300 tests
 - June 30 100 tests
- Multicultural Coalition's "Volleyball & Vaccine" event (Kiwanis Park)
 - July 28 Breanna & Chuck interacted with dozens of local families and individuals and handed out over 100 covid tests
 - Had "At Home Test Guidance" translated into Hmong (the clinic was focused on getting to Hmong families in the area)

Monkeypox

- Numbers
 - 26 Positive cases (of orthopoxvirus, presumed to be monkeypox) in Wisconsin (WI DHS as of Aug 5th)
 - 5 Positive cases (probable & confirmed) in Appleton (AHD notes as of Aug 8th)
 - 1 Suspect case in Appleton AHD notes as of Aug 8th)
- Vaccines
 - Received: 50 doses
 - Vaccinated: 8
 - Doses still available to use: 42 doses (don't necessarily need to be saved for second doses at this time)
