Item: Dedication of Public Right-of-Way, Milis Drive

GENERAL INFORMATION

Owner/Applicant: City of Appleton; Owner Tom Kromm, City Surveyor; Applicant

Location: Generally located north of E. Midway Road, west of Eisenhower Drive, and south of E. Vantage Drive

Petitioner's Request: Public road dedication to connect existing Milis Drive to Eisenhower Drive

BACKGROUND_

The applicant has completed a Certified Survey Map subdividing the adjacent property to the north and the south of the proposed dedication area into two remnant lots. The City currently owns the area being dedicated for future roadway purposes. The CSM will be approved conditioned on the acceptance of the subject land for dedicated public right-of-way by the Plan Commission and Common Council.

STAFF ANALYSIS

Public Right-of-Way Dedication: Approximately 1.9428 acres (84,628 square feet) of land is included in the proposed right-of-way dedication.

Street Classification: The City's Arterial/Collector Plan identifies this portion of Milis Drive as a local street.

Surrounding Zoning and Land Uses:

- North: M-1- Southpoint Commerce Park
- South: M-1- Southpoint Commerce Park
- East: M-1- Southpoint Commerce Park
- West: M-1- Southpoint Commerce Park

2010-2030 Comprehensive Plan: The City of Appleton 2010-2030 Comprehensive Plan identifies this area for future Business/Industrial uses. The proposed public land dedication is consistent with the following goal of the 2010-2030 Comprehensive Plan:


• **Goal 4 – Transportation** (Chapter 6)
