

Dear Ms. Johnson:

I am in receipt of your tax payment timeliness appeal form. As noted on the form, the Board only has the authority to overturn late payments when the payment is delinquent due to a postal delay or error (ie. letters mailed after 7:00 pm are dated the next day, mail is not picked up during a snow storm, or a check is lost in the mail). The Board does not have the authority to overturn late payments for the following reasons:

- -Forgot but had good intentions
- -Many years as a timely taxpayer
- -Illness, divorce, death, hospitalization
- -Didn't know/understand the process
- -Never received the tax bill
- -Financial hardship

It appears you are requesting review of your payment because your on-line check provider failed to issue your tax payment in a timely manner. While I understand that the situation was out of your control, it appears the issue is with your on-line check provider and not with the postal service. While I sympathize with your situation, unfortunately it does not appear that this reason would qualify for overturning the late payment. Please understand the Board's discretion in these matters is extremely limited by State Statute as described above.
