Estimate of Staff Time Spent on Fines-Related Transactions

During the month of December 2019, service desk staff completed a brief study to try to track fines-related transactions. We looked at:

- Fines-related transactions under 5 minutes and over 5 minutes long
- Transactions escalated to a supervisor
- Cash register transactions
- PIF transactions
- Other processes, including reconciling the cash drawer, replenishing drawer for following day, deposits, TRIP, Collections, bank runs, paperwork for refunds and payments to other libraries, etc.

From the data collected we estimate *40-120 hours per month are spent on fines-related transactions. If staff pay rates for clerks, library assistants, librarians, and supervisors are averaged to \$22.48/hour (based on PS team hourly rates), the estimated hours per month spent on fines-related transactions would translate to \$10,790 - \$32,371 per year.

^{*}Why the large range of hours? Because staff tally of interactions didn't match register transactions, we believe fines-related transactions were severely underreported during our study. December was also a slower month based on the monthly deposit and observation.
