- WISCONSIN POLLUTANT DISCHARGE ELIMINATION SYSTEM
- THIRD PERMIT CYCLE
- EFFECTIVE MAY 1, 2019
- EXPIRES APRIL 30, 2024
- STORMWATER WATER QUALITY DISCHARGE PERMIT
- WISCONSIN VERSION OF NPDES

KEY TERMS

- MS4 = MUNICIPAL SEPARATE STORM SEWER SYSTEM
- TMDL = TOTAL MAXIMUM DAILY LOAD
- GREEN INFRASTRUCTURE = RAIN GARDENS, BIOFILTERS, POROUS PAVEMENT (NOT PIPES)
- IDDE = ILLICIT DISCHARGE DETECTION AND ELIMINATION
- TSS= TOTAL SUSPENDED SOLIDS
- TP = TOTAL PHOSPHORUS
- BMP = BEST MANAGEMENT PRACTICE
- NEWSC = NORTHEAST WISCONSIN STORMWATER CONSORTIUM

- OUTSTANDING AND EXCEPTIONAL RESOURCE WATERS NONE FOR APPLETON
- IMPAIRED WATERS 303D LIST ALL APPLETON RECEIVING WATERS
- 1.5 IMPAIRED WATERS AND TMDL REQUIREMENTS (TIED TO 2.7)
- 1.9 GENERAL STORMWATER DISCHARGE LIMITATIONS
 - NO TRASH, ODOR, SCUM, OIL, ETC AT PIPE OUTFALLS
 - NO INTERFERENCE WITH PUBLIC RIGHTS TO WATERS OF THE STATE

- DUTY TO COMPLY, MITIGATE, HALT OR REDUCE ACTIVITY, PROVIDE INFORMATION, ETC.
- ENFORCEMENT ACTION POTENTIAL FINE OF UP TO \$10,000 PER DAY OF A VIOLATION
- RECORDS RETENTION
- SPILL REPORTING

 - DEVELOPMENT
 - NEW MS4 DISCHARGE OF A POLLUTANT
 - WASTELOAD ALLOCATION OR WLA
 - "STORM WATER POLLUTION PREVENTION PLANNING" CHANGED TO "STORM WATER POLLUTION PREVENTION PLAN OR SWPPP"

- ALL ARE NEW TO THE PERMIT
- REQUIREMENTS FOR MEETING TMDL GOALS WITHIN THE PERMIT TERM
- BASED ON EPA DATE OF APPROVAL OF A TMDL
- ONLY APPENDIX A AND APPENDIX C APPLY TO APPLETON
- TIED TO PERMIT SECTION 1.5
- LAST CITY-WIDE PLAN COMPLETED IN 2014
- NEXT UPDATE PROGRAMMED FOR 2020-2021 APPLIED FOR PLANNING GRANT
