

Title: Petition against the proposed design of narrowing the street of the two blocks of S. Driscoll Street in the city of Appleton and within Outagamie County.

Target: To The City Of Appleton

Petition Statement:

We, the undersigned residents are writing to express our strong opposition to the proposed design for S. Driscoll Street which involves the narrowing of the street from currently being 32 feet down to 26 feet. The proposed design poses major concerns for the property owners and tenants who reside on S. Driscoll Street.

The concerns are as follows:

- Residential recycle and disposal trucks being able to safely turn around and/or back up down the street to W. Charles Street to turn around to then back up back down S. Driscoll Street for the west side of the street properties to be picked up.
- Commercial disposal trucks which comes on Monday's and Thursday's who typically swing out wide to enter the exit driveway (south end of the bldg) of the apartment building located at 1401 S. Driscoll Street, since the driveway is pretty narrow, and then exit out the entrance driveway (north end of the bldg). Most of the time there's a vehicle parked illegally on the street south of the entrance driveway and then the driver has to swing quite wide out of the entrance driveway to miss the vehicle parked there which then he's almost touching the curb on the east side of the street with his front tires, other times he's barely makes it pulling out normally since his truck is quite long and this is at 32 feet he has issues.
- EMS (Fire Trucks, Ambulance and/or Police Squads etc.) have been dispatched to S. Driscoll Street more frequently they typically park all on one side which leaves barely enough room

for one lane of travel due to people parking on the west side of the street.

- There's been an increasing problem with double parking on the north end of S. Driscoll Street for the past three years on a daily basis and hasn't been addressed to where people driving in either direction have hard time passing the illegally parked vehicle (i.e.: UPS, FedEx, Amazon, Large Furniture Delivery Trucks, tenants of the duplex and/or bldg and visitors).
- Some property owners own trailers, boats, and/or campers etc. having issues being able to back them up into their driveway.
- City of Appleton maintenance vehicles (i.e.: plows, leaf removal trucks, street sweepers, etc.) currently have issues with being able to turn around due to people being parked on one side and/or both sides of S. Driscoll Street and to do what they originally came down the street to do.

The Ask: We urge The City of Appleton to vote against the proposed design for S. Driscoll Street and just replace the damaged street of which was proposed and/or to be completed in 2024.
